Prevention Category. Last 2 years we have done billboards, do not have funds for that this year. Any ideas on what we should do? Banners maybe? Banners may be a cheaper and more sustainable options. Then they can keep their banners in their schools? It was suggested to do social media posts leading up to Red Ribbon Week, mention community organizations who may be celebrating or participating in Red Ribbon Week. Last year the ribbons were great and the Park would display those again if wanted.

- Veronica mentioned maybe doing something through the Community Foundation for a downtown mural. They are wanting to get more Art downtown, maybe the winner could paint a wall mural.
