Meeting Notes (Old/New Business, Decisions, Agendas)

- Red Ribbon breakfast will be Saturday October 26th. Any members who want to volunteer that day please put a star next to your name on the sign in sheet. We do not have budget for a billboard, but a few members had figured out a way to have the high school students design a mural. Veronica shared that Mike Anderson on 3rd Street is donating the side of his building to be used for a mural. They want it to be on their detail shop wall though and that one faces the Farmers Market. They would like for it to be on something they can mount, not painted directly on the wall.
